II. Reservation of Seats:

- 10% seats are reserved over and above the intake to a degree Programme for NRIs / Children of NRI, or candidates sponsored by NRI. In addition, 5% seats reserved for foreign students, who enter through ICAR, can also be converted to NRI Quota (the decision of considering the seats to a degree or to a college is strictly lies with the KSNUAHS, Shivamogga).
- Definition of NRI candidate / NRI sponsored candidate shall be as outlined by Govt. of India / Karnataka NRI Policy 2017 as defined by Karnataka Education Authority.

III. Application and fee:

1. Applications are available, in PDF format, for downloading from the University website: uahs.edu.in from 17-11-2022 (Thursday) to 07-12-2022 (Wednesday).
2. The candidates are mandatory to pay the application fee of Rs. 1500/- (Rupees One Thousand Five Hundred Only) through DD drawn in favour of **Comptroller, UAHS, Shivamogga**. DD should be dated between 17-11-2022 to 07-12-2022 only. DD purchased after specified period are not valid (those already submitted application for First Counseling need not apply a fresh or DD but have to submit a letter for consideration in Second Counseling).
3. Application needs to be submitted along with the copies of educational documents including medical certificate and DD to the Registrar, Keladi Shivappa Nayaka University of Agricultural and Horticultural Sciences, Iruvacki, Shivamogga either in person or by post on or before from **07-12-2022 (up to 4:30 PM)**. For any postal delay university is not responsible.
4. Late submitted / incomplete applications / applications without payment of prescribed fees will not be considered.
5. Furnishing any false information in the application by the candidates is liable for cancellation of admission.

IV. Institutional Economic fee/Infrastructure fee:

1. For B.Sc. (Hons.) Forestry degree programme, NRI/Children of NRI / candidate sponsored by NRI shall pay US \$ 6,000 per year (Six Thousand US dollars only or equivalent in Indian Rupees per annum) as Institutional Economic Fee/Infrastructure fee which is prescribed by Government. Semester and other fee prescribed by the University, from time to time, shall be extra.
2. For B.Sc. (Hons.) Agriculture degree programme, NRI/Children of NRI / candidate sponsored by NRI shall pay US \$ 5,500 per year (Five Thousand Five Hundred US dollars only or equivalent in Indian Rupees per annum) as Institutional Economic Fee / Institutional Infrastructure fee, as prescribed by Government. Semester and other fee prescribed by the University, from time to time, shall be extra.
3. For B.Sc. (Hons.) Horticulture degree programme, NRI/Children of NRI / candidate sponsored by NRI shall pay US \$ 4,000 per year (Four Thousand US dollars only or equivalent in Indian Rupees per annum) as Institutional Economic Fee / Institutional Infrastructure fee, as prescribed by Government. Semester and other fee prescribed by the University, from time to time, shall be extra.

V. Undertakings by candidate, parents and sponsorer:

1. The sponsored candidate is required to tender an undertaking to the effect that, he or she would pay the Institutional economic fee and semester and other fees regularly to the University. In the event of Non-payment of fee, the student shall be terminated from the studies.
2. In addition, the sponsorer shall also submit an undertaking that, he / she has sponsored the candidate and will pay fee regularly till the candidate completes the course. In case the sponsorer fails to pay the fee, the sponsored candidate shall be terminated from the studies.
3. The sponsorer and the candidate, shall submit the undertaking on a stamp paper of face value of Rs. 100/- or equivalent currency signed by Notary should accompany the application.
4. No concession of fee is considered during the course period.

VI. Receipt of application, scrutiny and seat allotment:

1. After the last date of submission of filled in application, a committee constituted at the University level shall verify the documents submitted by the candidates. The lists, eligible and non-eligible, of candidates will be placed in the University Website. Candidates are advised to visit KSNUAHS, Iruvacki, Shivamogga website uahs.edu.in at least twice a day for the latest updates. No separate information will be sent to the candidates through mail or post.

2. The UG NRI Counseling cum admission date has been fixed on 16-12-2022 (Wednesday).
3. The venue shall be Office of the Registrar, Sharavathi Administrative Block, 2nd Floor, Iruvacki, Aandapura (H), Sagara (Tq.) Shivamogga-577 412. Karnataka (the venue may be relocated subjected to Bank availability).
4. KSNUAHS banks with Canara Bank. The exchange rate declared by Canara Bank on the day of conuselling shall be considered for collection of fees.
5. The seat allotment shall be on the basis of First preference franchised by the candidate (as per their application already submitted), based on the merit (already notified) and also seat availability in respective subjects/colleges. Only after the first preference is exhausted and seats are still available, then the II preference shall be considered.
6. Allotment of seats shall be strictly based on percentage of marks obtained in the examinations and subjects as specified in Table I. If students have secured same marks or %, in such circumstances SSLC marks shall be considered. In case the two or more candidates obtained equal marks at SSLC level, in such circumstances the date of birth of candidates shall be considered for allotment.
7. The prescribed institutional economic fee need to be paid by the candidate on the date of counseling (hence it is requested ward and parents to come prepared for paying the fees) either by paying cash or through NEFT or DD drawn in favour of Comptroller, KSNUAHS, Shivamogga.
8. If the admitted candidate wishes to cancel admission, either immediately or at a later date or year, the paid institutional fee is not refunded at any circumstances.
9. Similarly, the Semester prescribed fee paid by the candidate or the concerned, on behalf of candidate, will not be refunded by the University under any circumstances. However, the Caution Money Deposited of the candidate is refundable.
10. Seats allotted to a respective college are not interchangeable.

VII. Documents to be produced by the candidate/s at the time of counseling and joining the degree programmes:

1. All original transcripts about the Examinations passed (SSLC, PUC Science (10+2) (Intermediate) / Date of Birth certificate / Transfer Certificate/ Caste Certificate/ Aadhar Card /371 (J) Certificate (if any).
2. NRI status of sponsorer: NRI status and others – Passport and other residential proof or OCI (Overseas Citizens of India) or Green Card Holder or sponsorer citizenship, work permit or recent Income tax filed by the sponsorer or Sponsorer recent bank statement other certificates (related to stay particulars).
3. The candidate shall submit the Medical Fitness certificate issued from Govt. Hospital duly signed by a surgeon.
4. An undertaking to be submitted by the candidate, parent and the sponsorer that they will pay fee in dollars / equivalent Indian rupees regularly till the candidate completes the degree programme and in the event of non-payment of fee, his / her admission may be cancelled (Annexure-I &II).

VII. Fees to be paid by the candidate for seeking admission to hostels in constituent Colleges at Keladi Shivappa Nayaka University of Agricultural and Horticultural Sciences, Iruvacki, Shivamogga (Subject to availability of the hostel rooms and as per the hostel regulations prescribed.
