Other issues discussed

 Principal Secretary suggested to demark the boundaries in all the campuses and complete the geo reference fencing. The immediate action is to be taken to protect University property under land grabbing Act 2011. The status is to be reviewed in every Board Meeting.

It is requested through E-mail on 18-02-2020 to send the details and status of land allotted to college/research stations under the jurisdiction of UAHS, Shivamogga to initiate the action (Decision of 34th BoM).

In the present Board meeting, the matter was discussed and it was decided that by the end of May, land record status of every station needs to be collected. Further, issues of excess or less land situation due to disputes of civil cases or pending in DC/AC court need to be addressed. By the end of June, with the help of mines department or NITK, Surathkal or with Dept. of Oceanography, DGPS needs to be procured and survey for each station should be taken up. For each Board of Management meeting the updates needs to be given (Action: Estate Officer/Director of Research).
