Other issues discussed

- 1. The Hon'ble Board Member Sri. Aruna Kumar raised a concern for Leaf spot disease servility and requested to disclose what efforts made by University and what programmes undertaken/initiated to reduce the severity.
- 2. The Hon'ble Board Members raised a question to clarify whether Librarian salary in being drown from HRMS working at Iruvakki campus. Chairman answered that Assistant Librarian has been appointed on a contractual basis and not University Librarian.
- 3. A. Hon'ble Board Members suggested to nominate one person to act as Liaison Officers on a permanent basis.
 - B. Hon'ble Board Members informed that the general letter send to Govt for approval of Isreal Trip is not sufficient but the personal details of Hon'ble Board Members is required as per the Government direction such as Name, Age, Adhar No./PAN No., passport number to be collected and compiled to submit to Govt. for approval.
- 4. A. A few Hon'ble Members suggested to reverting back to Gown and Hood system for forthcoming Convocations from the present Dress code. Both Sri Shivaram and Sri Aruna Kumar pleaded to maintain the present dress code based on the recommendations of UGC and also Concept of Swadeshi. However, Chairman concluded that it will be discussed in the officers meeting then it will be brought for discussion in the ensuring BoM.
 - B. Hon'ble Board Members requested to include all the names in the Invitation Card of Convocation as per UAS Bangalore. Chairman informed that it will be verified and implemented.
- 5. The Hon'ble Board Members suggested preparing list of Board Members to be displayed in New Board Meeting Hall on a permanent basis.
- 6. The Hon'ble Board Members suggested introducing the Preface of all Hon'ble Board Members in College Magazines.
- 7. The Hon'ble Board Member raised objection about address printed and suggested to include "Hon'ble Member of the Board of Management" while dispatching the cards/invitation letters.
- 8. The Board Members requested to share one copy of the Act and Statutes of the University.
- 9. The Hon'ble Board Members suggested including them when meetings are held about Krishmela and other University functions.
